# תעודת כשרות

## KOSHER CERTIFICATE

הנני מאשר כי המכליות של חברת סטובה בהולנד עומדות תחת השגחתנו וכל מכלית שהפרטים שלה רשומות במסמך מיוחד השתמשו בה בשלש פעמים אחרונות רק במוצרים כשרים. מכליות אלו עברו תהליך הכשרה ונקיון יסודי במים ופוגם ואח"כ ברותחים ושוב בפורשים, וראוים להבאת מוצרים כשרים למהדרין. מקום ניקוי המכליות והעברת נוזלים למכליות קטנות עומד בהשגחתנו. אין תוקף כשרות לתעודה זו ללא מסמך נפרד עם פרטי המכלית. ח"ש ביום ט"ז טבת תשפ"ו לפ"ק.


Undersigned, Rabbi P.A. Meyers, declares that **Stubbe Logistiek** (Stubbe BV and Stubbe Cleaning BV) in **Gouda** and **Stolwijk the Netherlands** is under his supervision. Included in the kosher certification is transport, logistic and cleaning station of Stubbe in the Netherlands.

**Kosher transport:** tankers mentioned in a separate document are kosher cleaned and made available for the transport of kosher products according to the details mentioned in each document. Every document must specify the tanker and/or container, order number, last three transports, the kosher transport and the date the tanker was kosher cleaned.

**Kosher cleaning:** upon request are tankers cleaned according the kosher rules. On cleaning certificate will be added 'kosher cleaning P26' or 'kosher cleaning 30 minutes steam'. Before kosher transport there will be a special cleaning comprising the standard cleaning, followed by 30 minutes steam. The exception to this is if the transport company has its own kosher certificate. Than the kosher certificate must specify the tanker and order number, the last three previous cargoes, the kosher transport and the date container was cleaned.

**Kosher logistic:** dedicated load or blending and de-bagging process is kosher certified. This is done in a special dedicated kosher line and only with new drums and/or IBC containers. The responsibility of the kosher value of the products are by with the client. Before the load of kosher products there is done a special kosher cleaning, comprising the standard cleaning.

This kosher certificate is signed on 5 January 2026 and valid until 1 February 2027.
